

- Please update the Information Center or Security Guard on any changes of phone numbers, addresses, emergency contacts and service personnel.
- Please make sure you clean up after your dogs at all times. There are complaints about the mess left behind.
- Reminder—Heron Creek is a deed restricted community. Any changes to the exterior of your home has to be approved through the Archictural Review Committee (ARC) before any construction begins on your home. This includes but not limited to painting, solar panels, landscape changes, pool or spa installations. Please request the change in writing and bring to the Information Center.
- If you need to park an RV overnight, we will accom-

modate you for 48 hours. The RV must be parked at the empty lot next to the clubhouse. Please stop by the Information Center to pick up a parking pass.

- We are in the process of making an annual phone books whereas we will only mail updates. Please ensure you phone numbers and names are spelled correctly.
- Please do not block the driveways with your vehicles or your vehicles in the road or cul-de-sac overnight.. There are several walkers in the community and they are having a hard time maneuvering around the vehicles.
- Please remember that our staff works very hard doing the best job possible. Unfortunately mishaps can happen. Our staff is being trained on an ongoing basis to handle your concerns within the development. If they fall short of your expectations, please ask to speak to management so the matter may be addressed in a positive manner. Hello Heron Creek. For all of our new residents, my name is Dave Lawrence and I am the account manager at Heron Creek for Valley Crest. In this issue of the newsletter I thought we would talk about what we as a company do here with the lawn maintenance.

In 2003 Valley Crest is contracted to do yearly:

- Mow—40 times
- Hard edge 40 times
- Line trim—40 times
- Edge beds—20 times
- Fertilize 5 times
- Trim Shrub—10 times
- Irrigation checks—12 times

And the shrubs and palms are fertilized 2 times a year.

This gives you a brief description of what we do at Heron Creek ,however if you have a problem with your lawns, please call the Information Center at 423-6755 and place a work order. We will try to respond

within 72 hours or sooner however if there is an emergency we will respond as soon as possible.

If there are any concerns with the maintenance of your landscaping or you would like to have additional landscaping put into your yard, please call the Information Center at 423-6755 and the staff will fill out a work order.
